The SDGs are the following and our business is focused on all three pillars of economic, social and environmental aspects.








4. Energy monitoring

Goldair Cargo S.A. monitors energy consumption since the beginning of its operations. Monthly reports are kept. During the last three years energy consumption remains very stable around 700 MW per year. Energy consumption has been reduced by 0.7% compared to 2021 actual consumption.












5. Water monitoring


The company has been monitoring water consumption since 2012. Water consumption in 2022 has been reduced by 7,6% compared to 2021. All these records are kept and projected on monthly water monitoring reports in order to provide clarity and transparency.





6. Waste monitoring

Goldair Cargo S.A. manages all generated waste that is produced during its operation. For this purpose, it has set up special areas for waste management, while through licensed contractors it manages the packaging waste produced. Yearly, more than 100 tons of waste is managed by these contractors. All waste generated is recorded and declared on the special platform of the Ministry of Environment.



7. Managing Carbon

Goldair Cargo S.A. is committed to carbon management and its reduction. From 2023 it will start recording Scope I and Scope II carbon emissions.

8. Trainings

Training in Goldair Cargo S.A. is continuous. A variety of trainings that include important incentives for environmental management subjects are yearly organized.
